OUR SEASON INCLUDED PRODUCTIONS OF HENRY V DIRECTED BY ARTISTIC DIRECTOR DAVIS MCCALLUM, LOVES LABORS LOST DIRECTED BY AMANDA DEHNERT, AND A WORLD PREMIERE OF A NEW MUSICAL, PENELOPE, COMPOSED BY ALEX BECHTEL, CO WRITTEN BY EVA STEINMETZ AND GRACE MCLEAN, AND DIRECTED BY EVA STEINMETZ. THE SEASON REACHED OVER 16,000 AUDIENCE MEMBERS THROUGH IN-PERSON ATTENDANCE.
